Crane helped create the FBI's Cyber Behavioural Analysis Center (CBAC), which takes an asymmetric approach to examining cyber threats by combining the traditional behavioural concepts used for decades in the violent crime world with technical expertise to gain a holistic understanding of adversary techniques and behavioural characteristics of cyber actors.

During the dinner, Crane will share some fascinating insights into a case study on a UK/Nigerian cyber gang who went after 50,000 CFOs in a systematic way to defraud those organisations, exposing their operations and techniques.

Conducted under The Chatham House Rule, this discussion will be co-chaired by a CISO. Clive Room is the MC for the evening.
