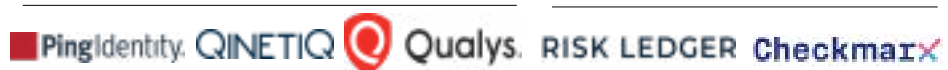

Meet the Board Directors - Talk to the Board 2023



Dame Inga Beale
Former CEO,
Lloyd's of London

Dame Inga Beale took over the helm of the 330-year-old City financial institution Lloyd's of London in 2014, after working in senior leadership roles in some of the world's largest insurance companies. With over three decades of global business experience she was awarded her Damehood in 2017 for services to the UK economy. Before joining Lloyd's, Inga was Group CEO of Canopi with its principal operations at Lloyd's. Prior to that she was on the Global Management Board of Zurich Insurance Group. Earlier roles include Group CEO of Swiss reinsurer Conventum, and a variety of international leadership positions for GE Insurance Solutions. She started her career as an underwriter with Prudential in 1982. During her time at Lloyd's, Inga developed a culture of innovation and inclusion. She expanded the company's reach to new, high-growth markets including Asia and the Middle East, and delivered some of Lloyd's strongest financial results. As the first female CEO of Lloyd's, she played a key role in changing cultural perceptions and highlighting the importance of diversity and inclusion. Moreover, she tackles breaking glass ceilings, and building inclusive environments within the workplace. Inga also analyses the reasons behind a lack of trust in both governments and the corporate sector, as well as the rise in public emphasis on corporate responsibility, purpose, ethics and sustainable business models. Inga is a Patron of Insuring Women's Futures, an alliance of insurance and personal finance professionals helping to improve women's long-term financial resilience. She is also an ambassador of Stonewall's Development Council, and was awarded a Damehood for her influential work in driving the inclusion agenda for women and the LGBT community. She has served as President of the UK Chartered Insurance Institute, a member of the Geneva Association Board, and a member of the UK Government's Financial Services Trade and Investment Board. She now has a portfolio of non-executive director roles for a variety of multinational companies.



Dr. Alan Knight OBE
Group Director of Sustainability
Drax & Senior Associate, CISL

Alan has over 30 years' experience of working with global companies and governments on sustainability. In April 2021 he joined Drax as the Group Director of Sustainability. Drax's ambition is to be the world's first carbon negative power station and is the largest producer of biomass for energy. Prior to that, for seven years Alan was in the steel and mining sector as the Global Head of Sustainable Development for ArcelorMittal. He was Cochairman of ResponsibleSteel and served on the steering board of the Initiative for Responsible Mining. Alan created and chaired the Ebola Private Sector Mobilisation Group, which was a collaboration of over 100 companies sharing best practice and coordinating the corporate response to Ebola in West Africa. For this he was made a Clinton Global Citizen honouree in 2015. Previous to that he was Sustainability Director for Business and the Community (BITC) where he oversaw all their Corporate Sustainability Programmes. He advised the Virgin Group on sustainable development for seven years. Previously he has worked with global companies as diverse as B&Q where he led their entire Sustainability programme for 10 years. He was instrumental in founding and developing the Forest Stewardship Council. He held similar roles in the Parent company Kingfisher and SABMiller, the multibillion brewery company. For nine years he was a commissioner with the Sustainable Development Commission and he introduced the concept of "choice editing" into the product policy debate. He was awarded the OBE in June 1998, in 2005 the US-based Rainforest Alliance presented him with a lifelong award and in 2013 he was made an Honorary Fellow of the Society for the Environment.



Mike Coupe
Former CEO
Sainsbury's

Mike Coupe is considered to be a leading business authority. Mike held the position of CEO for Sainsbury plc from 2014-2020. Before retiring he is credited for turning the company around, through top-level trading, marketing, and online operations. As a business speaker, he instills in his corporate audiences the essential skills he used to lead a market, and share his experience of directing one of the UK's most established organisations. Coupe joined Sainsbury's in 2004. Immediately making a positive impression on the company, he rose through the ranks and was appointed responsible for online operations, marketing, and trading in 2010. In 2014, Mike was named CEO of Sainsbury's. Using his expert knowledge, he quickly established a strategic review to stay ahead of the evolving retail market. Mike championed Sainsbury's journey ahead of the competition through a complete digital transformation. From till-free stores to the digitisation of Nectar, the UK's largest loyalty scheme, through a website and an app, he revolutionised the retail giant's day to day practices. Mike led the business from making 5% of online sales to an impressive 20% and growing. Additional influential roles include the Executive Board Director of Asda and Non-Executive Director at Greene King plc. In 2020, Mike announced Sainsbury's new, more sustainable operations. The company has invested £1 billion into achieving net-zero carbon emissions by 2040, setting the standard for other supermarkets. Mike himself described the decision, stating that "we must recognise that living well now also means living sustainably", reflecting his commitment to the environment. Mike was director of Covid-19 testing at England's Test and Trace agency from September through to December 2020 and has been appointed as a non-executive director on the board of NHS England from January 2021.



Julian Wheatland
Formerly Chairman, SCL Group and
COO & CFO, Cambridge Analytica /
SCL Group of Companies

Julian Wheatland was formerly Chairman of SCL Group and COO & CFO of the Cambridge Analytica / SCL group of companies. From 2015 to 2018 he oversaw the growth of the group into one of the most influential data analytics companies in the world, employing ground-breaking analytics technology and targeted communications which have shaped the advertising industry and the debate around data privacy and personal data. In 2018, following the media controversy surrounding Cambridge Analytica, Wheatland stepped into the role of Group CEO in order to "clean up the mess". Julian is a veteran of fast-growing technology companies and an expert in the opportunities, pitfalls and dangers that scaling technology businesses can bring. He is a serial entrepreneur who has spent 25 years investing in, managing and advising breakthrough technology companies: matching their strategies to markets, managing the challenges of rapid growth, and delivering value for customers and investors. Julian Wheatland now serves as CEO of Brava Systems, the Enterprise Management System for the real estate industry. He began his career at PA Consulting, advising clients on the impact and opportunities created by online innovation. He moved into fund management in the mid-noughties investing into early stage cleantech and security tech companies and, from there, founded Hatton International, a specialist technology commercialisation business. Prior to Brava Systems, Julian was CEO of Cornerstone FS plc, a fintech company which he listed on AIM in 2021. He speaks publicly on managing tech growth, technology strategy and marketing, entrepreneurship, data ethics and the impact of AI on corporate operations.

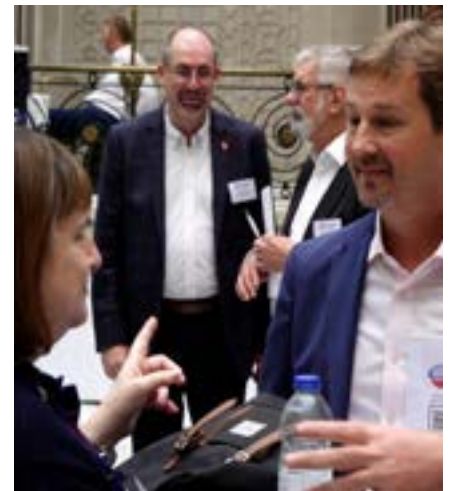

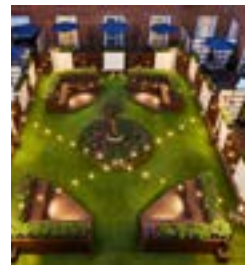
