ICONIC. A UNION OF HISTORY & INNOVATION

For over 152 years, the hotel has stood as a stunning testament to Victorian Gothic revival architecture – a beacon of pioneering design and elegance. 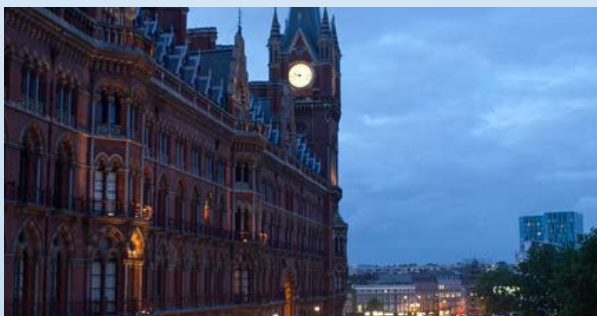
CONFERENCE SPACE: HANSOM HALL

Invented by Joseph Hansom in 1834, the Hansom Cab was a lightweight, two-wheeled carriage designed for speed and manoeuvrability, a staple of London's streets until 1947. The St. Pancras Renaissance Hotel's Hansom Hall and Bar occupies what was once the cobbled driveway where these carriages would collect passengers arriving at the station.

"The emerging consensus from Talk to the Board was how challenging it is for CISOs to present cyber risk to the board in an intelligible way for non-technical people. If your world is looking at cyber risk and you're a CISO, I would come to this event and get involved because you are sharing and gaining simultaneously."
