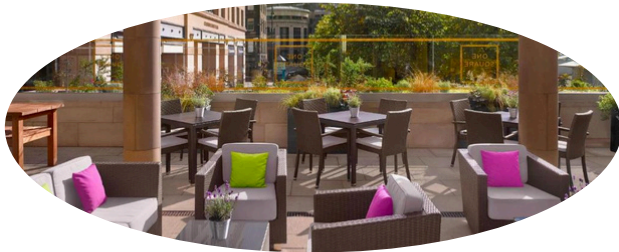

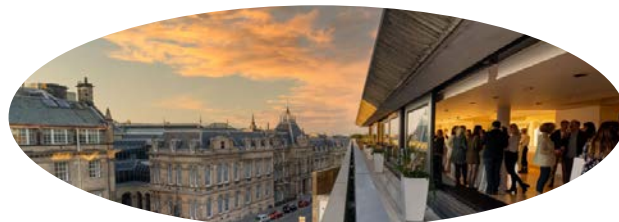


Cultural Experience - A Walk in The Vaults

The Candlelit Vaults Walk

Step beneath the surface into The Vaults and hidden layers.

Beneath Edinburgh's cobbled streets, through an unmarked doorway on South Bridge, lies a hidden world carved in stone in 1788, a place of shadow economies, illicit trade, survival, and stories the city never wrote into its official record. Once home to taverns, workshops, distilleries, and later the city's forgotten people, these chambers have held secrets for over two centuries. We venture underneath Edinburgh's Royal Mile for terrifying ghost stories on this guided tour of the city's underground which includes the Edinburgh Vaults, stone circle vault, and a torture exhibition. It's a setting that reminds us: resilience is rarely built in comfort and that trust can be forged in unusual spaces!
