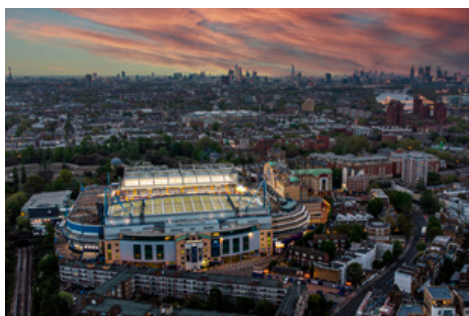

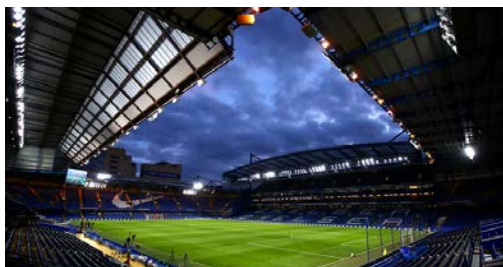
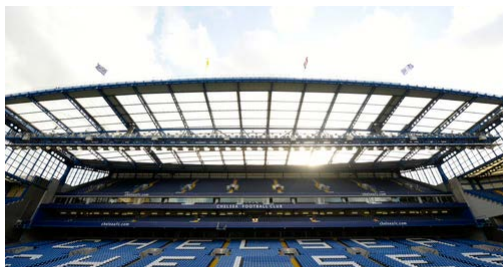

Tackling the Burning Questions at 'Talk to the Board'

Cybersecurity and corporate resilience have moved from operational risk to the boardroom.

"Cybersecurity started to appear as a postscript on the board agenda a few years ago. However, as concern over data breaches and their serious consequences has gained momentum, the priority level has increased. Today it should be top of the agenda, especially for consumer facing omni-channel businesses which rely on consumer confidence and customer data."

"I wanted to be part of the Talk to the Board event because I've always been so fascinated by technology, particularly what it brings on the dark side – the dark underbelly of technology being cyber attacks and the cyber risk. Being from the world of insurance, I was hoping to share some of my experience with assessing risk and managing risk because, fundamentally, this is what the CISOs are trying to do. I think they're doing an amazing job, but cybercriminals are always faster and quicker than any of us, so we must stay alert. From this event, I've learnt more about how lonely and vulnerable the CISO feels. I've been a CEO a few times and always felt the CEO took the can for everything. I thought then that people working lower in the organisation wouldn't feel so vulnerable. But I was hearing that from some of the attendees, and as boards, we need to think about how we can be more of a support for them so that they don't feel so lonely and perhaps under threat. If your world is looking at cyber risk and you're a CISO, I would come to this event and get involved because you are sharing and gaining simultaneously."
